NOTICE OF DISSOLUTION OF THE  
CENTRAL COMMITTEE OF ENUPF

October 9, 2006

The Central Committee of ENUPF (Ethiopian National United Patriotic Front) headed by Colonel Asrat Bogale of France, has been dissolved effective October 9, 2006 due to the resignation of more than half of the members of the Central Committee because of the following reasons.

1. The core organization ENUF and ENDF (Ethiopian National United Front and Ethiopian National Development Fund, respectively), established by the late Eng. Kitaw Ejigou, was joined in by Colonel Asrat Bogale and his so-called "patriotic forces". In the meeting held in February 17, 2006 in Atlanta, the Central Committee was entrusted with the job of overseeing and managing the operation of the front, as well as promote its mission.
2. Half of the Central Committee members were able to ascertain the none existence of any patriotic forces anywhere in the Sudan or Ethiopia, before or after the death of Eng. Kitaw.
3. Funds amounting up to \$60,000.00 (Sixty Thousand US Dollars) sent to the Sudan with the direction of the chairman, to support the so-called patriots were stolen by the two deceptive and criminal agents of the chairman.
4. Colonel Asrat Bogale, not only lied about the existence of his forces, but also failed miserably in carrying out his responsibilities to serve the organization honestly and with honor.
5. Colonel Asrat Bogale, not only deceived the members, but was viciously engaged in disseminating false and unrestrained propaganda against its two most important members of the central committee.
6. Colonel Asrat Bogale tried to discourage the functions of a special panel set up to "investigate the whereabouts of the stolen funds".

Therefore, the Central Committee residing in Atlanta, has dissolved for lack of a consensus and lack of trust in its chairman, who failed to carry on the banner of unity, civility, and patriotism. However, ENUF, the organization set up by the late Eng. Kitaw will continue to exist with all its members intact. ENUF is a pure and clean organization which is committed to bring down the Woyane regime and stop its unrestrained destruction of Ethiopia. ENUF will strive to promote peace, prosperity and ethnic harmony among all Ethiopians.

In the end, unselfish and honest Ethiopians will win the day.
